JEAN ELIZABETH was hustled to gain the lead while angling sharply to the rail, dictated the pace on a narrow margin into the turn and maintained that advantage to the end under firm encourage ment in a game effort. MISS DEPLORABLE tracked off the second flight outside foes racing to the turn, advanced four wide nearing upper stretch, shifted out five wide leaving the furlong marker but continued willingly to the end to close the gap on the pace setter. R HAPPY ENDING broke sharply, tracked just outside the pacesetter three deep racing to the turn, was urged to bid for command in that path in upper stretch but was outkicked by the top pair. ODE TO JOY tracked off the second flight along the inside racing into the turn, shifted out in upper stretch to bid four wide between foes leaving the furlong marker and continued willingly. ESCAPADE angled inwards to gain terms with the pacesetter prompting that rival into the turn, then to upper stretch but weakened late. JO JO AIR tracked just off the first flight along the rail racing into the turn but faded in late stages. ROCKYPOLICY settled well off the second flight while angling to the rail racing to the turn, angled out in upper stretch while being roused to gain some position but made no real impression. THIN KIN COWTOWN settled between foes in the last flight early, was fanned six wide into the stretch and proved no threat. AMBASSADOR LUNA tracked off the second flight between foes in the last flight, drifted out on the turn and trailed thereafter.
